**ORDER**

Consequent upon his exoneration in the Regular Departmental Enquiry initiated vide order No.684/SSP/Security & Traffic dated 03.10.2023 by Disciplinary Authority barring order No.D-332/SSP/Sec & Traffic dated 24.04.2026, Insp/LR Rohitash Kumar Yadav, No 697/CHG is, hereby, granted List-'F' and further promoted to the rank of Inspector of Police, in the pay matrix level-7 as per the Union Territory of Chandigarh Employees (revised Pay) Rules, 2023 retrospectively, w.e.f 14.08.2024, from the date his junior Insp/LR Satnam Singh, No.698/CHG (now Inspector) has been promoted as such in the light of recommendations of the DPC held on 14.08.2024.
