The above said assignment of 'look after charge' is subject to the following terms and conditions -

1. The above said assigning of look after charge of Dy.SP may not be considered as precedent for future in normal circumstances.
2. The Inspectors holding look after charge of routine duties of the post of Dy.SP will not be authorized for statutory duties of the Dy SP
3. This will be a temporary arrangement till this Administration fill up the posts of Dy. SP on regular basis, which is under active consideration.
4. No additional pay shall be admissible to the said officer(s) while looking after the charge of routine duties of the post. The officer(s) will not be entitled to claim any benefits such as seniority, pay and allowances attached to the post of Dy.SP and date of regular promotion to the post. This arrangement shall also not affect any inter-se-seniority.
5. This arrangement shall be liable to be discontinued at any time without assigning any reason(s).

Note: Before assigning the look after charge, Department will obtained written consent on the imposed conditions from the Inspectors, who will be assigned the look after charge.
