ORDER

On the recommendations of Departmental Promotion Committee held on 22.07.2026 and approved by the competent authority, the following police personnel are, hereby, granted Local Rank of Assistant Sub-Inspector(LR/ASI) of Police subject to the following conditions, with immediate effect:-

- (i) The HC/HC(PR),Sr.Constable/Constable who is to be considered for grant of ASI (LR), will be liable to be promoted on regular basis for further promotion as per his/her turn on seniority in his/her respective rank.
- (ii) Promotion of ASI (Local Rank) will be treated as purely personal rank.
- (iii) ASI (Local Rank) holder will be liable to wear the uniform of ASI.
- (iv) ASI (Local Rank) would not claim any financial benefits of higher pay, allowances and seniority.
- (v) After promotion as ASI (Local Rank) his seniority in the Head Constable cadre will not be changed.
- (vi) Rank of Assistant Sub-Inspector shall be personal to the official (without any monetary benefit or benefit of seniority).
