In exercise of the powers conferred under sub-rule (2) of Rule 6 of the Punjab Police Service Rules, 1959 as applicable to the Union Territory, Chandigarh, in pursuance of the orders of the Hon'ble High Court of Punjab and Haryana, Chandigarh dated 10.12.2015 and as per recommendations of the Departmental Promotion Committee held on 23.01.2018, the Administrator, Union Territory, Chandigarh is pleased to bring the name of Inspector Charanjit Singh Virk, No. 256/CHG on List 'G' with effect from the 30.01.2018.

The above said promotion is as per advice of the Central Vigilance Commission, New Delhi, conveyed vide their letter No. 016/02/UTS/004/37870, dated 08.05.2018 and subject to the following conditions:-
