In order to maintain a lavish life style, he used to steal the vehicles (Motorcycles & Cars) from different places in the city by using the master-keys and after using the stolen vehicles he used to abandon them in the free parking lots of the city.





Till yet, 08 Motorcycles & 01 Maruti Car, as per detail given below, have been recovered from his possession & his disclosure statement. With the recovery of these vehicles, 07 cases of vehicle theft registered with different police stations of the city have been worked-out: -
