GANG RESPONSIBLE FOR ORGANISED CHEATING IN RAILWAY EXAMS CAUGHT BY CYBER CRIME INV. CELL OF CHANDIGARH POLICE

06 ACCUSED ARRESTED

Sh Rajesh Kalia, DSP/ Cyber Crime Inv. Cell received a secret leakage of question paper of Railway information regarding recruitment Board Group D scheduled to be held on 08.12.13 at Chandigarh through mobile messages etc. On this information DSP/Cyber Crime Inv. Cell constituted a special team led by Insp. Jasbir Singh under his supervision to watch the activities of the candidates appearing for the said examination and the persons near the examination centers. While the team was present outside the examination Center No. 2052 & 2053 at Govt. Model Sr. Sec. School, Sector-46, Chandigarh, it was noticed that some of the candidates present there were busy on their mobile phones and preparing some coded slips. All those candidates were identified who prepared the coded slips containing answer keys and after that Insp Jasbir Singh contacted Smt Sudesh Raghav, Principal, GMSSS-46, Sh K.S. Sidhu, Vice Principal, GMSSS-46, Sh Harish Kumar & Rajat Arora, Senior Section Officers, Railway Department and apprised them about the facts and shared the information. After start of the exam the identified persons were found cheating with coded slips containing answer keys by the Smt Sudesh Raghav, Principal, GMSSS-46, Sh K.S. Sidhu, Vice Principal, GMSSS-46, alongwith their staff.

The six candidates namely (1) Narender S/o Satpal R/o VPO-Dhigal, Distt- Jhajjar, Haryana (2) Devender S/o Ramkumar R/o VPO-Rohat, Distt- Rohtak, Haryana (3) Kuldeep S/o Jogender R/o Dhigal,

Distt- Jhajjar, Haryana (4) Deepak Ahlawat S/o Sh Azad Singh R/o Vill- Bahrana, The- Beri, Distt-Jhajjar, Haryana (5) Gulab Singh S/o Sh Ranbir R/o VPO-Bhasrukala, Teh- Sampla, Distt- Rohtak, Haryana (6) Dalbir Singh S/o Sh Chanderbhan R/o Vill- Butana, PS-Baroda, Distt-Sonepat, Haryana found cheating with the coded slips containing answer keys. They were handed over to the Insp. Jasbir Singh and police party present there. On the complaint of Smt. Sudesh Raghav, Principal, GMSSS-46, Chandigarh Case FIR No. 714 dated 08.12.13 U/S 66 A IT Act & 420,120 B IPC was registered at PS-34, Chandigarh. During the course of investigation above candidates were arrested and four mobile phones through which they received the answer keys were recovered from their possession. Further raids are being conducted to arrest the other associates who leaked the papers and sent them answer keys through message. Further investigation is under process.
