Order

The appellant has preferred her 1st appeal against the reply order of CPIO/ Communication with the contentions that requisite information was not supplied to her, which was transferred from W/SSP/UT vide No. 44-46/UT/RTI/SSP dated 28.01.2019.

On perusing the RTI application and appeal as well as documents on file, it has been revealed that appellant had applied RTI application on 27.11.2018 which was disposed of by CPIO/ Communication vide letter No. RTI- 108/SP/Comn. dated 12.12.2018. Thereafter, she had applied her 1st appeal on 24.01.2019 after the gap of 13 days on the above prescribed period of 30 days.

Moreover, appellant was asked to explain the valid/cogent reason for condoning the delay vide letter No. 44-46UT/RTI/SSP dated 28.01.2019 so that instant appeal can be entertained as per RTI Act. In response to this letter, appellant had submitted her reply through email that delay was occurred due to unforeseen tragedies in close relatives which disrupted her attention.

But neither any date of tragedies to her relatives nor any supporting documents were provided by the appellant to justify her version. So, the reply of delay is inadequate and insufficient to condone the delay. Hence, the instant appeal is hereby filed, accordingly.
