This is an order on the appeal dated 12.02.2018, which was transferred from W/SSP/UT vide No. 71/RTI/SSP/UT. dated 13.02.2019 to this office, preferred by Sh Joginder Singh R/o # 553/1, Sector - 38/A, U.T., Chandigarh, under RTI Act, 2005 for not supplying complete information by CPIO-cum SP/Communication.

Facts:-

2. Vide RTI application dated 28.12.2018, the appellant had sought information of complaint filed by the applicant on 06 different points, out of which the following 34 & 5 Points pertained to CPIO/ Communication & CPIO/Lines respectively :-

- On 18 October applicant made a complaint on 100 no. dial, provide the copy with proceeding.
- Copy of complete list of vehicles and other things taken on rent/lease last of 2 years by the department @ along with rate of contract.

3. The Comments of CPIO/ Communication & CPIO/Lines were sought vide No 06 & 07/FAA/RTI/SP/Hqrs. dated 18.02.2019, whom intimated that information has already been supplied to the appellant, vide letter No. 01/RTI/CPIO/Lines dated 14.01.2019 & No. 123/RTI/CPIO/Comm. dated 09.01.2019.

4. The appeal was fixed for hearing on 11.03.2019 at 10.30 AM, both the CPIOs and Appellant were requested to present on hearing. During the hearing Appellant Joginder Singh demanded the list of recovery vans, which was provided by CPIO/Lines. The same was collected by appellant and gave in written that "received point no. 4 & 5 information complete".

DECISION

5. I have considered the appeal filed by the appellant viz-a-viz comments of CPIO/Communication & CPIO/Lines. Since the necessary reply/information to his RTI application has been provided by the CPIO/Lines & CPIO/Comm., as such, the appeal is disposed of, accordingly.
