**ORDER**

The appellant has preferred his 1<sup>st</sup> appeal against the reply/order of CPIO/East with the contentions that requisite information was not supplied to him. The same was diarized vide No. R-29/UT/RTI/FAA/SSP dated 16.02.2019.

**Information sought vide RTI application :**

The appellant vide his RTI application had sought information on 3 points pertaining to complaint No. 2018-14785 i.e. statements of Mrs. Renu Jaiswal, Dr. Sangeeta, Nursing Home 323 Sector 21A, Chandigarh along with documents submitted by her.

**Comments of CPIO/East :**

CPIO/East submitted that RTI application of the appellant was received in his office for supplying requisite information i.e. statements of Mrs. Renu Jaiswal, Dr. Sangeeta, Nursing Home 323 Sector 21A, Chandigarh along with documents submitted by her in complaint No. 2018-14785. The complaint in question was under enquiry in PS-19. Hence, information was denied to the applicant u/s 8(1) (h) of RTI Act. As far as the appeal is concerned, the said complaint is still under enquiry. Hence, requisite information cannot be to the appellant at this stage also.

**Decision :**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/East vis-à-vis material available on record which

revealed that the appellant had sought information on 3 points pertaining to complaint No. 2018-14785 i.e. statements of Mrs. Renu Jaiswal, Dr. Sangeeta Nursing Home 323 Sector 21A, Chandigarh along with documents submitted by her.

In reply, CPIO/East denied the requisite information to the appellant u/s 8(1) (h) of RTI act.

So far as the appeal is concerned, the complaint in question is still under enquiry and requisite information cannot be supplied to the appellant at this stage. Hence, the requisite information is denied u/s 8(1) (h) of RTI act.

However, considering the fact that appellant is the complainant in aforementioned complaint, therefore, CPIO/East is hereby directed to cooperate with him and inform the progress of his complaint. CPIO is also directed to supply the requisite information to the appellant as per RTI Act as and when the above enquiry is completed.

With aforementioned observations, the appeal of the appellant is disposed of accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, as above, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
