**ORDER**

The appellant has preferred his 1<sup>st</sup> appeal against the reply/order of CPIO/East with the contentions that requisite information was not supplied to him. The appeal was received from the office of CPIO/East on 05.03.2019 and the same was diarized vide No. R-39/UT/RTI/SSP dated 05.03.2019 for further proceeding in accordance with RTI Act.

**Information sought vide RTI application:**

The appellant had sought the copy of action taken report on his compliant bearing No. PW201811738 regarding fair investigation in case FIR no. 207 dated 06.07.2018, PS-Ind. Area, UT, Chandigarh.

**Comments of CPIO/East**

CPIO/East submitted that RTI application was received in his office from CPIO/PHQ vide letter No. 1257/DSP/Hqrs/RTI-18/D-1526 dated 02.01.2019. for supplying the requisite information. Thereafter, relevant information was obtained SHO/ Ind. Area who reported that complaint No. Pw 201811738 was attached with case FIR No. 207 dated 06.07.2018 and the same was under enquiry at that time and requisite information was denied u/s 8(1) (h) of RTI Act. As far as the appeal is concerned, complaint in question is still under enquiry, the same could not be supplied at this time.

**Decision :**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/East vis-à-vis material available on record which revealed that the appellant had sought the copy of action taken report on his compliant bearing No. PW201811738 regarding fair investigation in case FIR no. 207 dated 06.07.2018, PS-Ind. Area, UT, Chandigarh.

In reply, CPIO/East had submitted that requisite information was denied to the appellant u/s 8(1) (h) of RTI act.

So far as the appeal is concerned, complaint in question is still under enquiry; therefore, the requisite information cannot be supplied at this time to the appellant.

However, considering the fact that appellant is the complainant in the aforementioned complaint, hence, CPIO is hereby directed to cooperate with the appellant and apprise the progress status of the above complaint to the appellant. He is further directed to supply the requisite information in accordance with RTI act, as and when the enquiry is completed.

With these observations, the appeal stands disposed of accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, as above, he can file second appeal within 90 days under the RTI Act before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi – 110067.
