



**THE SUPERINTENDENT OF POLICE HQs.-CUM-APPELLATE AUTHORITY-
TRAINING, UNDER RIGHT TO INFORMATION ACT, 2005.**

Order on First Appeal u/s 19 RTI Act.

This is an order on the appeal bearing no. PODEP/A/E/20/00031 dated 17.05.2020 preferred by Ms. Geeta R/o H. No. # 1666, Sector 8, Faridabad, Haryana under RTI Act 2005, received in this office online through RTI portal, against disposal of her RTI application No. PODEP/R/E/20/00125 dated 14.04.2020 by CPIO/Training.

2. The appellant, vide her online RTI application, had requested Nodal Officer-HQs. to supply her some information pertaining to recruitment of 520 constables in Chandigarh Police in 05 points. Nodal Officer further transferred the said RTI application to CPIO//Training and the same was disposed of on 08.05.2020.

3. The appellant, not satisfied with the manner in which her application was disposed of by CPIO/Training filed the instant appeal alleging that the CPIO has provided Incomplete, Misleading and False information.

4. The comments of DSP-cum-CPIO/Training have been called for. She has reported that the appellant filed an online RTI application/request on 14.04.2020 vide No. PODEP/R/E/20/00125, to supply the information regarding the CBT exam of 520 constables in five points. The application was sent to the incharge recruitment cell (CAPIO) for reply on 16.04.2020. In charge Recruitment cell replied on 05.05.2020 that standard normalization procedure has been adopted at the time of selection of questions across all shifts. Further, reply of RTI application has been provided supplied to the applicant on 08.05.2020. Now the appellant has added one more point in the appeal to inspect the related documents.

5. I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments by CPIO/Training. The appellant, through RTI application, had sought information relating to CBT exam of 520 constables recently conducted by Chandigarh Police. The information sought by the appellant, supplied by the CPIO, grievance of the appellant and the order/decision of the undersigned being first appellate authority is given below:

Point No. 5 Please provide me information of algorithm formula of provisional merit list and separately for revised merit list. I seek information on all same points mentioned in RTI application /detailed documents in my first appeal. Please allow me to inspect related documents, I request you to please provide me correct information.	

The appeal is disposed of accordingly.

The appellant, if not satisfied with the disposal of appeal in the manner as above can file second appeal with the Hon'ble Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munrika, New Delhi-110067 within a period of 90 days.
