UNDER RIGHT TO INFORMATION ACT, 2005.

Order on First Appeal u/s 19 RTI Act.

This is an order on the online First Appeal bearing no. PODEP/A/E/20/00037 on 19.05.2020 preferred by Ms. Uma Rani R/o House No. 84, Near Shiv Mandir, VPO Jaula Kalan, Teh. Derabassi, Distt. Mohali, Punjab Pin. 140501 under RTI Act 2005, received in this office online through RTI Request & Appeal Management Information System (RTI-MIS), against disposal of her online RTI Application bearing no. PODEP/R/E/20/00114 dated 11.04.2020 by CPIO/Training.

1. The appellant, vide her online RTI application under RTI Act 2005, had requested Nodal Officer-HQs. to supply her some information pertaining to recruitment of 520 constables in Chandigarh Police in 04 points. Nodal Officer further transferred the said RTI application to CPIO//Training who disposed of the same on 06.05.2020.
2. The appellant, not satisfied with the manner in which her application was disposed of by CPIO/Training and filed the instant appeal alleging that CPIO has provided incomplete, Misleading or false information.
3. The comments of DSP-cum-CPIO/Training have been called for. She has reported that the appellant filed an online RTI application/request on 11.04.2020 vide No.PODEP/R/E/000114, to supply the information regarding the CBT exam of 520 Constables on 04 points. The application was sent to the in-charge Recruitment Cell (CAPIO) for reply on 13.04.2020. In charge Recruitment cell replied on 01.05.2020 that the result and answer key of CBT was declared on 31.12.2018. After the declaration of result, some representations were received by Chandigarh Police on the issue of incorrect question/answer key. Due to this, the result had to be withdrawn and cancelled. On the basis of these representations, Chandigarh Police had directed the Service Provider engaged for CBT to get all questions and answer key of CBT independently scrutinized by a panel of reputed subject matter experts. Thereafter, all the candidates were duly informed to login to the "**Answer Key Grievance Redressal System**" on the website of Chandigarh Police to view their individual attempted question paper and revised answer key as per their batch during the period starting from 0900 hours on 31.01.2019 to 0900 hours on 02.02.2019. **Further, candidates were also provided another opportunity to raise grievances regarding the revised answer key.** A total of 2185 grievances regarding 361 questions were received from 791 candidates. All the grievances received from candidates have been examined by two independent panels of subject matter experts. As per the scrutiny report of the two independent panels of subject matter experts, out of a total of 700 questions of CBT, the answer key of 11 questions has been revised

and 10 questions have been declared invalid. While these 10 incorrect questions have not been considered for evaluation but in order to achieve parity across all batches, the total marks obtained by candidates have been extrapolated against 100 questions. The reply/requisite information was online disposed of/sent online to the appellant on 06-05-2020. Now the appellant has added one more point in the appeal to inspect the related documents.


4. I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments by CPIO/Training. The appellant, through RTI application, had sought information relating to CBT exam of 520 constables recently conducted by Chandigarh Police. The information sought by the appellant, supplied by the CPIO, grievance of the appellant and the order/decision of the undersigned being first appellate authority is given below:
