

THE SUPERINTENDENT OF POLICE HQs.-CUM-APPELLATE AUTHORITY-TRAINING, UNDER RIGHT TO INFORMATION ACT, 2005.

Order on First Appeal u/s 19 RTI Act.

This is an order on the First Appeal bearing no. PODEP/A/E/20/00038 on 19.05.2020 preferred by Ms. Uma Rani R/o House No. 84, Near Shiv Mandir, VPO Jaula Kalan, Teh. Derabassi, Distt. Mohali, Punjab Pin. 140501 under RTI Act 2005, received in this office online through RTI Request & Appeal Management Information System (RTI-MIS), against disposal of her online RTI Application bearing no. PODEP/R/E/20/00122 dated 12.04.2020 by CPIO/Training.

- 1. The appellant, vide her online RTI application under RTI Act 2005, had requested Nodal Officer-HQs. to supply her some information pertaining to recruitment of 520 constables in Chandigarh Police in 05 points. Nodal Officer further transferred the said RTI application to CPIO//Training and the same was disposed of on 08.05.2020.
- 2. The appellant, not satisfied with the manner in which her application was disposed of by CPIO/Training filed the instant appeal alleging that CPIO provided incomplete, Misleading or false information.
- The comments of DSP-cum-CPIO/Training have been called for. She has reported that the appellant filed an online RTI application/request vide No. PODEP/R/E/20/00122 dtd. 12.04.2020, to supply information regarding the CBT exam of 520 constables in 05 points. The application was sent to the in-charge recruitment cell (CAPIO) for reply on 16.04.2020. In charge Recruitment cell replied on 04.05.2020 that "Yes, Standard Normalization procedure has been adopted at the time of selection of questions across all shifts". The reply/requisite information was disposed of/supplied to the appellant online on 08.05.2020.
- I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments by CPIO/Training. The appellant, through RTI application, had sought information relating to CBT exam of 520 constables recently conducted by Chandigarh Police. The information sought by the appellant, supplied by the CPIO, grievance of the appellant and the order/decision of the undersigned being first appellate authority is given below:

In accordance with the instruction no.21 of Online roll number exam admit card standard normalization procedure will be adopted to insure parity in questions across all shifts of CBT (held on 15th, 16th, 17th November 2018 and 20th December 2018) exam conducted in multiple session for this multiple session paper suitable normalization is applied to take into account any variation in the difficulty level of question paper across all shifts. Yes, Standard normalization procedure has been adopted at the time of selection of questions across all shifts		The undersigned being appellate authority agrees with the CPIO informing the appellant that standard normalization procedure had been adopted in all the shifts of the examination. However regarding points no. 2 & 5, the CPIO is directed to either supply the information free of cost within 10 days of issue of this order or deny it with reasoning why it can not be supplied.

Point No. 2

Kindly provide me the information which formula was adopted for calculating the normalized marks or the multi-session papers.

Point No. 3

Please provide me information about whether you include 7th shift paper in standard normalization procedure adopted or not include.

Point No. 4

Please provide me the information have you adopted normalization for the provisional Merit list result as well as revised merit result.

Point No. 5

Please provide me information of algorithm formula of provisional merit list and separately for revised merit list.

Point No. 1

Kindly provide me the information have you adopted standard normalization procedure or not adopted (yes/no)

Point No. 2

Kindly provide me the information which formula adopted in hard copy for calculating the normalized marks or the multi-session papers.

Point No. 3

Please provide me information about whether you include 7th shift paper in standard normalization procedure or not include (yes/no) provide me in hard copy reply for this point.

Point No. 4

Please provide me the information have you adopted normalization for the provisional Merit list result as well as revised merit result.

Point No. 5

Please provide me information of algorithm formula in hard copy of provisional merit list and separately for revised merit list.

I request you to please provide me correct information.

The appeal is disposed of accordingly.

The appellant, if not satisfied with the disposal of appeal in the manner as above can file second appeal with the Hon'ble Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munrika, New Delhi-110067 within a period of 90 days.
