

THE SUPERINTENDENT OF POLICE HQs.-CUM-APPELLATE AUTHORITY-TRAINING. UNDER RIGHT TO INFORMATION ACT. 2005.

Order on First Appeal u/s 19 RTI Act.

This is an order on the online First Appeal bearing no. PODEP/A/E/20/00035 dtd. 19.05.2020 preferred by Ms. Reena R/o H.No. 348, Sector-7A, Chandigarh under RTI Act 2005, received in this office online through RTI Request & Appeal Management Information System (RTI-MIS), against disposal of her online RTI Application bearing no. PODEP/R/E/20/00137 dated 21.04.2020 by CPIO/Training.

- The appellant, vide her online RTI application under RTI Act 2005, had requested Nodal Officer-HQs. to supply her some information pertaining to recruitment of 520 constables in Chandigarh Police in 06 points. Nodal Officer further transferred the said RTI application to CPIO//Training and the same was disposed of by her on 15.05.2020.
- 2. The appellant, not satisfied with the manner in which her application was disposed of by CPIO/Training and filed the instant appeal alleging that the CPIO did not provide her the information sought in RTI application.
- 3 The comments of DSP-cum-CPIO/Training have been called for. She has reported that the appellant filed an online RTI application/request on 21.04.2020 vide No. PODEP/R/E/20/00137, to supply the information regarding the CBT exam of 520 constables on 06 points. The application was sent to the in-charge recruitment cell (CAPIO) for reply on 23.04.2020. The reply from the recruitment cell was received on 12.05.2020 that the information about marks obtained by all candidates in revised merit list was informed through their registered email address (given at the time of registration). Further, the desired information is denied under section 8(1)(j) of the Right to information Act 2005. Standard normalization procedure has been adopted at the time of selection question across all shifts. The desired information on point no. 5 & 6 is not available with the recruitment cell. The reply/requisite information was supplied/disposed of online to the applicant on 15.05.2020.
- 4. I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments by CPIO/Training. The appellant, through RTI application, had sought information relating to CBT exam of 520 constables conducted by Chandigarh Police. The information sought by the appellant, supplied by the CPIO, grievance of the appellant and the order/decision of the undersigned being first appellate authority is given below:
