1. This is an order on the 1<sup>st</sup> appeal received from SSP/UT vide letter No. D-127/UT/RTI/ FAA/SSP dated 11.05.2021 filed by Mrs Vanita Sharma, H.No. 408, Vill – Darwa, Chandigarh (UT) against his RTI application dated 12.02.2021 received vide Incharge Public Window (PHQ) letter No. 187/RTI/CAPIO(PHQ)/UT/PWS dated 24.02.2021 for supplying requisite information.
  2. The appellant filed the instant appeal that CPIO/Accounts & Procurement be directed to supply the salary details of last seven years in respect of Incharge Police Post Darwa Parminder Singh, Constable Sandeep, Hitesh, Umed and Munishi Darwa Police Post as mentioned in point No. 14 of RTI Application.
  3. Appellant vide this office letter No. 15/RTI/CPIO(Accts)/2021/5057 dated 09.03.2021 has been intimated that information on salary in respect of police personnel presently posted in PS-Darwa is a third party information which is exempted under Section 8(1)(j) of RTI Act, 2005.
  4. CPIO/Accounts & Procurement as well as the appellant were asked to appear in the office of the undersigned on 27.05.2021 at 03.00 PM in order to discuss the information available for supply. As per request of appellant, next date of hearing was fixed on 09.06.2021. CPIO/Accounts as well as dealing staff were present but the appellant did not appear on the said dates.
  5. Due to absence of appellant on the dates as mentioned in para 4 above, next date of hearing was fixed on 16.06.2021 but the appellant did not appear.

**Decision.**

6. I agree with reply of CPIO/Accounts & Procurement that information sought by the appellant is a third party information which is exempted under Section 8(1)(j) of RTI Act, 2005. Therefore, the appeal is disposed off.
