ORDER

The appellant has preferred his 1st appeal against the reply/order of CPIO/W&CSU in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide no. 215/UT/RTI/FAA/SSP dated 17.12.2019 for further proceeding under RTI Act.

Information sought vide RTI application : -

The appellant had sought the information pertaining to complaint filed by Jasbir Kaur i.e. Copy of complaint, action taken on legal notice and details of massi, maternal cousin, mama etc.

Comments of CPIO/W&CSU:-

CPIO/W&CSU reported that RTI application of the appellant was received in his office on 10.10.2019 for seeking information pertaining to complaint filed by Jasbir Kaur bearing PWS no. 2019-15101. Thereafter, requisite information was obtained from SHO Women Police Station and the appropriate reply was sent to the appellant through registered post on 04.11.2019. As far as the appeal is concerned, available information was sent to the appellant.

ecision :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/W&CSU vis-à-vis material available on record which revealed that the appellant had sought the information pertaining to complaint filed by Jasbir Kaur i.e. Copy of complaint, action taken on legal notice and details of massi, maternal cousin, mama etc.

In reply, CPIO/W&CSU had supplied the copy of complaint to the appellant. However, with regard to rest of the information, appellant was informed that the matter of legal notice is under consideration and detail of relatives of complainant (Jasbir Kaur) was not provided by her in her complaint.

It is also pertinent to mention here that the whole matter is related to matrimonial dispute and the appellant is father-in-law of the complainant. The complaint in question, is still under enquiry with Woman Police Station.

In view of above, CPIO/W&CSU is hereby directed to supply the remaining information to the appellant in accordance with RTI act as and when the enquiry is finalized. With these observations, the instant appeal stands disposed of accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
