

**THE ADMINISTRATIVE OFFICER PHQs.-CUM-FIRST APPELLATE AUTHORITY-
ESTABLISHMENT, UNDER RIGHT TO INFORMATION ACT, 2005.**

Order on First Appeal u/s 19 RTI Act.


1. This is an order on the First Appeal dated 25.03.2021 preferred by Sh. Ajay Kumar S/o Sh. Lautu Ram, # 164/A, Police Station 26, Sector-26, Chandigarh under RTI Act 2005, received in this office on 01.02.2021, against disposal of his RTI application by CPIO/Estt.
2. The appellant, vide his RTI application, had requested CPIO/Estb. To supply him some information pertaining to Sh. Ajay Kumar. The same was disposed of by CPIO/Estt. Vide no. 17/RTI-21/CPIO(Estt)/UT/7402 DATED 02.03.2021.
3. The appellant, not satisfied with the manner in which his application was disposed of by the CPIO filed the instant appeal alleging the CPIO had supplied him incomplete, misleading and false information.
4. The comments of Supdt-cum-CPIO/Estt have been called for she has reported that she has supplied the sought information.
5. I have gone through the RTI appeal, vis-à-vis facts of the RTI application & comments by CPIO/Estt. The information sought by the appellant, supplied by the CPIO grievance of the appellant and the order/decision of the undersigned being first appellate authority is given below:-

I, being first Appellate Authority do not agree with the CPIO not supplying the information citing the reason that it is already available in public domain. The appellant has sought the certified copy of the Hon'ble CAT and High Court's judgement. The CPIO/Estt is directed to provide the certified copy of the documents if available with her on record.

Point No.2 Certified copy of direction/Notification/Circular issued in this regard from Department of Personnel of Personnel & Training Govt. of India to Chandigarh Administration i.e. Home Secretary/Adviser UT Chandigarh/Department of Personnel Home UT/Chandigarh Police to implement the said orders in all Department of Chandigarh Administration as well as Chandigarh Police.	As per directions of Hon'ble Court.	I have not been provided any information/record from CPIO (Establishment) PHQ-9, Chandigarh	I do not agree with the CPIO. The reply of the CPIO differs with that of the information sought. However, the appellant has also failed to pinpoint any specific order or document with its date or memo number. Numerous references are received from various departments including DoPT. He is advised to seek the documents with its date or number of his choice.

6. The appeal is disposed of accordingly.

7. The appellant, if not satisfied with the disposal of appeal in the manner as above can file second appeal with the Hon'ble Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munrika, New Delhi-110067 within a period of 90 days.
