Order on First Appeal u/s 19 RTI Act.

- 1. This is an order on the First Appeal dated 25.03.2021 preferred by Sh. Ajay Kumar S/o Sh. Lautu Ram, # 164/A, Police Station 26, Sector-26, Chandigarh under RTI Act 2005, received in this office on 01.02.2021, against disposal of his RTI application by CPIO/Estt.
- 2. The appellant, vide his RTI application, had requested CPIO/Estb. To supply him some information pertaining to Sh. Ajay Kumar. The same was disposed of by CPIO/Estt. Vide no. 17/RTI-21/CPIO(Estt)/UT/7402 DATED 02.03.2021.
- 3. The appellant, not satisfied with the manner in which his application was disposed of by the CPIO filed the instant appeal alleging the CPIO had supplied him incomplete, misleading and false information.
- 4. The comments of Supdt-cum-CPIO/Estt have been called for she has reported that she has supplied the sought information.
