ORDER

Order on First Appeal u/s 19 RTI Act.

This is an order on the appeal dated 17.06.2020 preferred by Sh. Harbhajan Singh R/o Village Gilzian, PO-Miani, Hoshiarpur, Punjab under RTI Act 2005, received in this office through the office of SSP/UT-cum-appellate authority on 26.06.2020, against the disposal of his RTI Application dated 12.05.2020.

- 1. The appellant, vide his application dated 12.05.2020 under RTI Act 2005, had requested PIO/SSP, Chandigarh to supply him information about any secret complaint on his name, photo or vehicle number i.e. PB-07AD-7344 during the period 01.03.2020 to 10.05.2020. The RTI application was transferred by Incharge Public Window-cum-CAPIO/HQs. to CPIO/East, South, Central & Crime, vide No. 455/RTI/CAPIO(PHQ)/UT/PWS, dated 15.05.2020. The undersigned is the appellate authority w.r.t. CPIO/Crime only.
- 2. The appellant, not satisfied with the manner in which his RTI application was disposed of by CPIOs/East and Central, filed the instant appeal alleging that the CPIOs has provided him incomplete, misleading and false information.
- 3. The comments of DSP-cum-CPIO/Crime have been called for. He has reported that RTI application of Sh. Harbhajan Singh was received in his office through CAPIO/PHQ vide No. 455/RTI/CAPIO (PHQ)/UT/PWS, dated 15.05.2020 to supply the information about any secret complaint on the applicants name, photo, vehicle number i.e. PB07AD7344 during the period 01.03.2020 to 10.05.2020, in any police station/units of Chandigarh Police. Report into the matter was obtained from I/C MOB, Sector-17, Chandigarh. As per report, nothing found on the name of Sh. Harbhajan Singh Ghotra and the available information in the office of MOB i.e. Vehicle Enquiry Report and Vehicle Details was also provided to the applicant vide No. 19/RTI/CPIO/Crime, Chandigarh dated 03.06.2020. Here, it is pertinent to mention that applicant is not satisfied with the RTI report of CPIO/Central & East, whereas no more action is warranted on the part of CPIO/Crime.
- 4. I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments by CPIO/Crime. The information sought by the appellant, supplied by the CPIO, grievance of the appellant and the order/decision of the undersigned being first appellate authority is given below:
