**O R D E R**

The appellant has preferred his online 1<sup>st</sup> appeal (bearing registration no. PODEP/A/E/20/00102 dated 26.12.2020) against the reply/order of CPIO/South in connection with his online RTI application (bearing registration no. PODEP/R/E/20/000592 dated 26.11.2020) with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide no. 150/UT/RTI/FAA/SSP dated 26.12.2020 for further proceeding under RTI Act.

**INFORMATION SOUGHT IN RTI APPLICATION:-**

The appellant had sought information on 05 points pertaining to case FIR No. 233 dated 21.07.2017, PS-36, Chandigarh i.e. status of cancelation of report, Action Taken Report against erring officer and complete case file etc.

**COMMENTS OF CPIO/South: -**

CPIO/South submitted that online RTI application of the appellant was received online for obtaining information on 5 point pertaining to case FIR No. 233/2017 dated 21.07.2017, PS-36, Chandigarh.

Thereafter, point wise reply was supplied to the appellant vide letter No. 500/CPIO/South dated 22.12.2020

**DECISION :-**

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that appellant had sought information on 05 points pertaining to case FIR No. 233 dated 21.07.2017, PS-36, Chandigarh i.e. status of cancelation of report, Action Taken Report against erring officer and complete case file etc.

Insofar as appeal is concerned, appellant has raised his grievances under the instant appeal. His grievances cannot be entertained under RTI Act as RTI act provides a mechanism for seeking information to the appellant but it is not a appropriate platform/forum for redressing his grievances. Whereas, CPIO/South had already furnished the points wise reply/information to the appellant, hence, no more action is warranted and instant appeal is hereby disposed of.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
