ORDER

The appellant has preferred his 1st appeal (through e-mail) on 18.04.2020, received on 20.04.2020 against the reply/order of CPIO/Central in connection with his RTI application dated 11.02.2019, received on 12.02.2020 with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide no. 34/UT/RTI/FAA/SSP dated 20.04.2020 for further proceeding under RTI Act.

Information sought vide RTI application :-

The appellant had sought information on 03 points pertaining to his complaint dated 27.07.2018 regarding illegally obtaining of call details of his mobile no. 93160-13011, details of case regarding which call details were obtained and name of Investigating officer etc.

Comments of CPIO/Central :-

Comments of CPIO/Central have been obtained who submitted that RTI application of the appellant was received in his office from CAPIO/PHQ vide letter no. 235/RTI/CAPIO/PHQ/UT/PWS dated 12.02.2020. Thereafter, the requisite information was obtained from SHO PS Sector 03 and the appellant was informed vide letter no. 50/RTI/20/CPIO/Central/UT dated 02.03.2020 that no complaint dated 27.07.2018 of the appellant was found received in PS Sector 03, Chandigarh. However, as per mail record, CDR, CAF, call details & location of mobile no. 93160-13011 were obtained by SI Mohan Lal, the then I/C PP Lake in connection with case FIR no. 134 dated 22.06.2018 u/s 420, 34 IPC PS 03, Chandigarh. As far as the appeal is concerned, on 22.04.2020 the appellant was contacted on his given mobile no. 9316013011 and apprised that no complaint dated 27.07.2018 was received in PS Sector 03 but rest of the information was supplied to him. Hence, no more information is pending on the part of CPIO/Central.

Decision :-


I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record which revealed that appellant had sought information on 03 points pertaining to his complaint dated 27.07.2018 regarding illegally obtaining of call details of his mobile no. 93160-13011, details of case regarding which call details were obtained and name of Investigating officer etc.

In reply, CPIO/Central had informed the appellant that no complaint dated 27.07.2018 of the appellant was found received in PS Sector 03, Chandigarh. However, as per mail record, CDR, CAF, call details & location of mobile no. 93160-13011 were obtained by SI Mohan Lal, the then I/C PP Lake in connection with case FIR no. 134 dated 22.06.2018 u/s 420, 34 IPC PS 03, Chandigarh.

So far as the appeal is concerned, CPIO/Central submitted that the appellant was contacted telephonically and apprised that no complaint dated 27.07.2018 was received in PS Sector 03 but rest of the information was supplied to him. No more information is pending on his part.

In view of above, it is clarified that available information was supplied to the appellant. Hence, no more action is required to be taken on the instant appeal, the same is hereby filed accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
