ORDER

Order on First Appeal u/s 19 RTI Act.

This is an order on the appeal dated 17.08.2020 preferred by Dr. Mohit Dhawan, # 1197, Sector 21-B, Chandigarh under RTI Act 2005, received in this office through email id of Dr. Mohit Dhawan i.e. drmohitdhawan@gmail.com on the same day, against disposal of his RTI application dated 09/07/2020, by CPIO/Crime. The above said appeal is also transferred to this office from the o/o Director General of Police and SSP/UT vide No. 3776/SO/DGP/UT and D-313/UT/RTI/FAA/SSP dated 17.08.2020, respectively.

- 1. The appellant, vide his RTI application dated 09.07.2020 under RTI Act 2005, had requested CPIO/PHQ, Sector-9, Chandigarh to supply him information in 03 points pertaining to public window complaint No. PW-201816563 dated 03.10.2018, PW-201817339 dated 15.10.2018, PW-201817740 dated 19.10.2018, PW-201816130 dated 27.09.2018, PW-201816245 dated 28.09.2018 and PW-201817747 dated 19.10.2018 dealt by Crime Branch, Sector-11, Chandigarh. The said RTI application was submitted at Jan Sampark Centre Sector-21, Chandigarh by the applicant vide No. jsc21/2020/81 dated 11.07.2020 and the same was transferred to DSP-cum-CPIO/Crime by CAPIO/HQs. vide no. 606/RTI/CAPIO(PHQ)/UT/PWS dated 17.07.2020. The said RTI application was disposed of by CPIO/Crime, vide no. 29/RTI/CPIO Crime dated 11.08.2020.
- 2. The appellant, not satisfied with the manner, his RTI application was disposed of by the CPIO/Crime, filed the instant appeal alleging that the CPIO has deliberately denied the information sought.
- The comments of DSP-cum-CPIO/Crime have been called for. He has reported that after going through the reference, the RTI information was denied u/s 8(1)(h)of RTI Act-2005 and section 8(1)(j)of RTI Act-2005 and sent to applicant within 30 days, as the receipt date of RTI application in CAPIO/PHQ office stands 15.07.2020. The applicant is a prime accused in FIR No.76 dated 19.03.2018 u/s 420,467,468,471 IPC, Police Station, Sector-19, Chandigarh. The information sought by applicant Dr. Mohit Dhawan relates to complaints which are against him. So, the information sought by applicant was denied, as the mentioned complaints are against him and under enquiry stage.
- 4. I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments by DSP-cum-CPIO/Crime. The information sought by the appellant, supplied by the CPIO, grievance of the appellant and the order/decision of the undersigned being first appellate authority is given below:
