

**THE SUPERINTENDENT OF POLICE, HQs.-CUM-APPELLATE
AUTHORITY, COMMUNICATION, UNDER RIGHT TO INFORMATION ACT,
2005.**

ORDER

Order on First Appeal u/s 19 RTI Act.

This is an order on the appeal dated nil preferred by Mr. D.R. Singla # 4961, Sector 38 West, Chandigarh under RTI Act 2005, received in this office on 06.01.2020, through SSP/UT-cum- First Appellate Authority, against the disposal of his RTI Application dated nil.

(2) The appellant, vide his application dated nil under RTI Act 2005, had requested CPIO-cum ASP/South to supply him some information pertaining to calls made by him on Police Nos. 100 & 112.. On point no.1, CPIO/South as well as CPIO/PHQs. transferred the application to CPIO/Communication who disposed of the RTI application vide No. RTI-184/SP/Comm./UT dated 16.12.2019.

(3) The appellant, not satisfied with the manner in which her application was disposed of, has filed the instant appeal.

(4) The comments of SP-cum-CPIO/Communication have been called for. He has reported that a RTI request of applicant was transferred to this office by CPIO(PHQs)/UT/PWS, dt. 21.11.2019 and the same was also transferred to this office by CPIO South, for supply of requisite information of Point No. 1, relates with call received from mobile nos. 7087079234 and 9876203222 during the last 2 years on 100 and 112 no. for Police help. So far as concern of point No. 1 pertain to this wing, the requisite information was procured from the Inspector Communication (Admn.) and the applicant was informed on 16-12-2019 (telephonically) to collect the reply from this office on the deposit of requisite fees. He assured to reach this office the next day and to collect the information. But, he did not came to this office on 17-12-2019 inspite of assurance given by him. **However, he visited this office on 23-12-2019 instead of 17-12-2019 and refused to pay the requisite fees of Rs. 30/- for obtaining the information, on the plea that he had filed an appeal in the matter as the information was not supplied to him timely. Whereas, he also given in writing that he was already informed by this office about this information on 16-12-2019.**

(5) I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments by CPIO/Training. The appellant, through RTI application, had sought information relating to calls made from two mobile numbers on police help line. Only point number 1 was related to CPIO/Communication. The information sought by the applicant, supplied by the CPIO, grievances raised by the appellant in RTI appeal and the order/decision of the undersigned being first appellate authority is given below:
