ORDER

The appellant has preferred his 1st appeal bearing no. PODEP/A/E/20/00020 dated 26.04.2020 against the reply/order of CPIO/South application bearing with his RTI Hqrs in connection PODEP/R/E/20/00095 dated 25.03.2020 with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide no. 38/UT/RTI/FAA/SSP dated 27.04.2020 for further proceeding under RTI Act. The instant appeal is also transferred to FAA-cum-SP/Hqrs as RTI application was dealt by CPIO/Hqrs with respect to many points concerning to his office.

Information sought vide RTI application:-

The appellant had sought information on 27 points pertaining to his complaints bearing nos. 2019-18168, 2019-19292 & 2019-19295, CRM-M No. 43616 of 2019, fact finding enquiry report, regular enquiry report, statements recorded, evidence collected, notings, orders, DDR entries, summons issued, CCTV footage & Call details etc.

Comments of CPIO/South :-

Comments of CPIO/South have been obtained who submitted that RTI application of the appellant was received in his office through RTI online portal vide registration no. PODEP/R/E/20/00095 dated 01.04.2020. Thereafter, relevant record was scrutinized and available information in point-wise form was sent to the appellant vide letter no. 145/CPIO/South dated 24.04.2020. As far as the appeal is concerned, appellant has already been informed that complaint files bearing nos. 2019-18168, 2019-19292 & 2019-19295 alongwith all relevant record, were sent to senior officers for final decision after completion of enquiries and the same are now consigned in HAC branch since 05.03.2020. Copies of order received from Hon'ble High Court in CRM-M No. 43616 of 2019 and thereafter, order of fact finding enquiry were supplied to the appellant. Moreover, petitioner was also informed that CCTV footage of camera installed at H. No. 2400-C, EWS flats, Sector 63, Chandigarh was checked but his house was not covered by the said camera. Rest of the information i.e. regular enquiry report, final enquiry reports of complaints in

testion, statements recorded, relevant DDR entries, summons, call details etc. are ttached with complaints files and enquiry files which are kept in the concerned branches under the supervision of DSP-cum-CPIO/Hqrs. Regarding which, RTI application was already transferred to CPIO/Hqrs by Nodal Officer RTI through Online RTI portal.

Decision :-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that all the requisite information of 27 points mainly related to the complaints filed by the appellant bearing nos. 2019-18168, 2019-19292 & 2019-19295, CRM-M No. 43616 of 2019, fact finding enquiry and regular enquiry which includes statements recorded, evidence collected, notings, orders, DDR entries, summons issued, CCTV footage & Call details etc.

CPIO/South has supplied all the available information at her disposal and also informed the appellant about all the available facts concerning to her office but she could not supply the complete information to the appellant as all the relevant information is attached with complaint files and enquiry files which are kept in the concerned branches under the supervision of DSP-cum-CPIO/Hqrs. Regarding which, RTI application has already been transferred to the office of CPIO/Hqrs by Nodal Officer RTI via Online RTI portal and the same was dealt by him.

Accordingly, instant 1st appeal is also transferred to SP/Hqrs being 1st Appellate Authority of CPIO/Hqrs for further proceedings at his own level.

In view of above, it is clear that appellant has already been informed about all the available facts by CPIO/South. For the remaining information, he should contact the office of FAA-cum-SP/Hqrs. Hence, no more action is required to be taken on the instant appeal, the same stands disposed as far as the office of the undersigned is concerned.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
