ALLOTMENT CYCLE-22 - Inviting applications for the Allotment of fresh/Change Police Pool houses of all categories upto 20.11.2020.

Applications are hereby invited from the eligible & willing employees of Chandigarh Police, as per the Allotment Rules (PPH), for the allotment of police pool houses as fresh/change (except Constables, Clerks, Class-IV employees who joined Chandigarh Police after 31.12.2009) on the prescribed proforma (Specimen available on the official website of Chandigarh Police i.e. www.chandigarhpolice.nic.in) duly filled and forwarded by the concerned G.O. (Supervisory officer) by 20.11.2020 {Friday}. The applications reached/diarized in the diary section of PHQ by 20.11.2020 will be entertained in the present cycle of allotment and the applications received/diarized after 20.11.2020 will be entertained during the next cycle of allotment.

No request for the change of choice of sector/change of house/withdrawal of 2. application will be entertained after the due date i.e. 20.11.2020 in the 22nd Cycle and houses available vacant, upto 20.11.2020 will be considered in this Cycle of allotment. Applications received after 20.11.2020 and houses received vacant after 20.11.2020 will be considered in next cycle i.e. 23rd cycle.

FORM NO.1

The employees who have no police pool house in their occupation or residing in the lower category of house and wants to apply higher type of house may apply on Form No.1.

FORM NO.2

Only Ex-servicemen employees who have no police pool house in their occupation or residing in the lower category of house and wants to apply higher type of house may apply on Form No.2.

FORM NO.3

Only the employees who are in occupation of police pool houses and want to change in the same category of house may apply on Form No.3.

An officer/official may apply for one category of house only to which he is entitled. Application Form submitted for allotment of house other than the entitled category would automatically stand rejected. The employees whose name already stands in the seniority lists maintained for the purpose of fresh/change allotment of house, in this office, need not to apply again.
