This is an order in online First Appeal bearing no. PODEP/A/E/23/00132 dated 16/12/2023, preferred by of Sh. Sarvjeet, R/o Valmiki Nagar, Ward No. 11, Charkhi Dadri, Haryana under RTI Act 2005, received in the office through RTI Request & Appeal Management Information System (RTI-MIS), against the disposal of his online RTI Application bearing No. PODEP/R/E/23/00961 dated 30/10/2023 by CPIO/Establishment.

Facts:-

- 2. Vide RTI application dated 30/10/2023, the appellant had sought information on 02 points related with the recruitment of constable in Chandigarh Police, which are as under:-
 - How much I scored in written examination in CHANDIGARH POLICE CONSTABLE exam on 23/07/2023 ?
 - 2. What was the Cut off marks for the candidates belongs to the SCHEDULE CASTE category and Other category called for Or selected for PET? Kindly provide me the above information, I shall be thankful to you. The Related Document is Also attached.

The said RTI application was dealt by CPIO/Establishment and same was disposed of vide no. 326/RTI-23/CPIO/Estt. 44957 dated 08.11.2023.

- The appellant, is not satisfied with the information supplied by the CPIO/Establishment against his RTI application and has filed the instant mentioning therein that "I filed RTI earlier but did not get any satisfying information. There is Information Chandigarh isprovided on the website of UT By using RTI Act 2005, I want to seek some following information regarding CHANDIGARH POLICE CONSTABLE RECRUITMENT 2023. I am SARVJEET bearing Roll no. 776620 Question booklet code -D. Who appeared in the exam on 23/07/2023 CHANDIGARH UNIVERSITY MOHALI. 1. How much I scored in written examination in CHANDIGARH POLICE CONSTABLE exam on 23/07/2023.
- 2. What was the Cut off marks for the candidates belongs to the SCHEDULE CASTE category and Other category called for Or selected for PET?"
- The Comments in this appeal were sought from DSP/Hqrs-cum-4. CPIO/Establishment. who intimated that the appellant vide his RTI application had requested to supply his marks in examination held on 23.07.2023 and category wise cut off marks for the post of constable in Chandigarh Police. As per the reports of the concerned branch i.e. E-2, the appellant has advised to visit the official website of Chandigarh Police requisite information has already been provided to appellant, vide office letter no. 326/RTI-23/CPIO/Estt./UT/44957 dated 08.11.2023.

DECISION

I have considered the appeal filed by t he appellant viz-a-viz comments of DSP/HQs-cum-CPIO/Establishment. The undersigned being First Appellant Authority found that the CPIO/Establishment has already supplied the official link of Chandigarh Police website, as the information sought by applicant is available on the website. Therefore, no more action is required in the matter. The appeal is hereby disposed of.
