## ORDER

The appellant has preferred his 1st appeal through online portal (bearing No. PODEP/A/E/20/00040 dated 25.05.2020) against the reply of CPIO/South in connection with his RTI application (bearing No. PODEP/R/E/20/00138 dated 22.04.2020) with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 44/UT/RTI/FAA/SSP dated 25.05.2020 for further proceeding under RTI Act.

## Information sought vide RTI application:

The appellant had sought copies of DDRs dated 05.09.2018, 12.09.2018 & 13.10.2018 and statements recorded by IO on the instructions of PCA relating to case FIR No. 284 dated 07.08.2018, PS-34, Chandigarh.

#### Comments of CPIO/South:

CPIO/South submitted that RTI application of the appellant was received through online portal for supplying the requisite information. Thereafter, requisite information was obtained from SHO/PS-34 and thereafter, point's wise reply was sent to the applicant vide No. 157/CPIO/South dated 20.05.2020.

### Decision:

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/South vis-à-vis material available on

record which revealed that appellant had sought copies of DDRs dated 05.09.2018, 12.09.2018 & 13.10.2018 and statements recorded by IO on the instructions of PCA relating to case FIR No. 284 dated 07.08.2018, PS-34, Chandigarh.

In reply, CPIO/South had denied the requisite information u/s 8(1)(h) of RTI to the appellant as the case is under investigation.

So far as the appeal is concerned, it is clear that case FIR No. 284 dated 07.08.2018, PS-34, is still under investigation and the same cannot be supplied to the appellant at this stage as per section 8(1) (h) of RTI Act. Hence, the instant appeal stands disposed off, accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days. 17/16/2020
