

**THE SUPERINTENDENT OF POLICE, HQs.-CUM-APPELLATE
AUTHORITY-HQs., UNDER RIGHT TO INFORMATION ACT, 2005.**

ORDER

Order on First Appeal u/s 19 RTI Act.

This is an order on the appeal dated 23.01.2020 preferred by Ms. Mini, H.N. 13, Street No. 3, R.K. Puram, near ITC gate, Saharanpur(UP) under RTI Act 2005, received in this office online, against the disposal of her RTI Application dated 27.12.2019.

(2) The appellant, vide her application dated 27.12.19 under RTI Act 2005, had requested CPIO-cum-DSP HQs. to supply her some information pertaining to a complaint made by one Sh. Gagandeep Singh against Smt. Meenu Rani bearing no. PW201102782. CPIO/HQs. disposed of the RTI application vide No. 392/DSP/Hqrs./Online RTI-19 D-06 dated 15.01.2020.

(3) The appellant, has filed the instant appeal on the ground that she is not satisfied with the response of the CPIO.

(4) The comments of DSP-cum-CPIO/HQs. have been called for. He has reported that on 31.12.19, I/C Public Window was directed to supply the requisite information who reported that as per public window record, complaint PW No. 201102782 sought under RTI has been consigned with HAC Branch. Accordingly on 10.01.2020, I/C HAC was directed to supply the relevant file/complaint. In response, he replied that complaint PW no. 201102782 had already been destroyed vide order No. 5211-45/UT/HAC dated 23.07.18 and the appellant was apprised through online RTI portal vide No. 392/DSP/Hqrs./Online RTI-19 D-06 dated 15.01.2020.

(5) I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments by CPIO/Training. The appellant has been contacted on her mobile no. 08221021151 on 13.02.2020 at 11.42 AM and offered personal hearing but she has expressed her inability. The information sought by the applicant, supplied by the CPIO, grievances raised by the appellant in RTI appeal and the order/decision of the undersigned being first appellate authority is given below:
