ORDER

The appellant has preferred his 1st appeal against the reply of CPIO/ W&CSU & PHQ in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal was received from O/o SP/HQ-cum-FAA vide letter No. D-962RTI/SP/HQ/UT dated 27.05.2020 and the same diarized vide No. 46/UT/RTI/FAA/SSP dated 28.05.2020 for further proceeding under RTI Act.

Information sought vide RTI application:

The appellant had sought information on 2 points relating to his complaint No. 2019-11080 i.e. certified copy of settlement agreement to settle marital dispute and other relevant documents.

Comments of CPIO/W&CSU:

CPIO/W&CSU submitted that RTI application of the appellant was received for supplying the requisite information. Thereafter, requisite information was obtained from SHO/WPS-17 who reported that complaint in question 2019-11080 was sent to senior officers, therefore, RTI

application was also transferred to CPIO/PHQ vide No. 116/UT/DSP/W&CSU dated 04.03.2020.

Comments of CPIO/PHQ:-

CPIO/PHQ submitted that RTI application was received from CPIO/W&CSU for supplying the requisite information. Thereafter, requisite information was obtained from I/C CRU who reported that complaint in question 2019-11080 is still under consideration with senior officers, therefore, the same was denied u/s 8(1)(h) of RTI act.

Decision:

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/W&CSU & PHQ vis-à-vis material available on record which revealed that appellant had sought information on 2 points relating to his complaint No. 2019-11080 i.e. certified copy of settlement agreement to settle marital dispute and other relevant documents.


In reply, CPIO/PHQ had denied the requisite information u/s 8(1) (h) of RTI to the appellant.

So far as the appeal is concerned, the present status of the complaint No. 2019-11080 is still under enquiry, therefore, the same cannot be supplied at this stage u/s 8(1)(h) of RTI Act. With these observations, the instant appeal stands disposed off.

- In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
