THE ADMINISTRATIVE OFFICER PHQs.-CUM-APPELLATE AUTHORITY-ESTABLISHMENT, UNDER RIGHT TO INFORMATION ACT, 2005.

Order on First Appeal u/s 19 RTI Act.

This is an order on the First Appeal bearing No. PODEP/A/E/20/00058 dated 21.07.2020 preferred by Sh. Dilip Kumar Kansal, R/O H.No. 3219, Near Mini Market, Sector-37/D, Chandigarh, under RTI Act 2005, received in this office on 22.07.2020 through DC/F&A, PHQ against disposal of his RTI application dated 24.06.2020 by CPIO/Estt.

- 2. The appellant, vide his RTI application, had requested CPIO/Estt. to supply him some information pertaining to Sub-Inspector Baljit Singh No. 1122/CHG. The same was disposed of by CPIO/Estt. vide no. 97/RTI-20/CPIO(Estt.)/UT/21609 dated 20.07.2020 by supplying point-wise information.
- 3. The appellant, not satisfied with the manner in which his application was disposed of by the CPIO filed the instant appeal alleging that he was not satisfied with the information supplied by the CPIO on points no. 1 and 5.

The comments of Supdt.-cum-CPIO/Estb. have been called for. She has reported that Sh. Baljit Singh No. 1122/CHG has retired from the service on 31.07.2020 and as per the record of this office, his permanent address as provided by E-10 branch is as under:

- Baljit Singh s/o Sh. Sarwan Singh

- District Ropar (Punjab)

However, with regard to point No. 5 i.e. property return, it is stated that it is a third party information and has not made any bonafide public interest. The disclosure of such information would cause unwanted invasion of privacy of the individual. Moreover, the official has given in writing not to supply his personal information to anyone. Hence the information was not provided to the applicant being third party information.

4. I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments by CPIO/Estt. The information sought by the appellant, supplied by the CPIO, grievance of the appellant and the order/decision of the undersigned being first appellate authority is given below:

the same on the ground that it was not available in his service book. But now in her comments, the CPIO/Estt. has traced the address of SI Baljit Singh from the office record which is as:

As far as declining of information regarding property return of SI Baljit Singh is concerned, the undersigned being first appellate authority agrees with the rejection of information by the CPIO u/s 8(1)(j) as third party information as disclosure would cause unwanted invasion of the privacy of SI Baljit Singh and its disclosure would not serve any larger public

interest.

4 All complaint regarding Baljit Singh the status may be given in under RTI act 2005.

One Complaint dated 10.06.2020 filed by Sh. Dilip Kumar is received in this office and the same is under process.

5 Property return of the Baljit Singh belt no 1122 may be supplied immediately under RTI act.

It is intimated that it is third party information and has not made any bonafide public interest The discloser of such information would cause unwanted invasive of privacy of the individual. Moreover, official has given in writing not his personal supply information to anyone. Hence the information cannot be provided being third party information.

The appeal is disposed of accordingly.

The appellant, if not satisfied with the disposal of appeal in the manner as above can file second appeal with the Hon'ble Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munrika, New Delhi-110067 within a period of 90 days.
