This is an order in online First Appeal bearing no. PODEP/A/E/23/00133 dated 21/12/2023, preferred by of Sh. Krishan R/o village- Dhanauri Khurd, Post Dankaur, Dist.- Gautam Buddha Nagar, Uttar Pradesh under RTI Act 2005, received in the office through RTI Request & Appeal Management Information System (RTI-MIS), against the disposal of his online RTI Application bearing No. PODEP/R/E/23/00929 dated 20/10/2023 by CPIO/Establishment.

Facts:-

2. Vide RTI application dated 20/10/2023, the appellant had sought information w.r.t. recruitment of constable in Chandigarh Police (executive) 2023, which is as under :-

" I had recently appeared in the CHANDIGARH POLICE Constable Exam 2023. My roll no is 721265 and Application no is CHDPL11121658. Sir I want my OMR Sheet to re-check my marks. Please send my OMR Sheet."

The said RTI application was dealt by CPIO/Establishment and same was disposed of vide no. 288/RTI-23/CPIO/Estt. 45164 dated 09.11.2023.

3. The appellant, is not satisfied with the information supplied by the CPIO/Establishment against his RTI application and has filed the instant mentioning therein that *"I recently appeared for the Chandigarh Police Constable Examination 2023. My roll no is 721265 and My application no is CHDPL11121658. Sir, I want my OMR sheet to re-check my actual marks which are more according to my calculation. So please send my OMR Sheet. "*

4. The Comments in this appeal were sought from DSP/Hqrs-cum-CPIO/Establishment, who intimated that the appellant vide his RTI application had requested to supply his OMR Sheet of constable recruitment exam-2023 in Chandigarh Police. As per the reports of the concerned branch i.e. E-2, the appellant has been advised to visit the official website of Chandigarh Police, vide office letter no. 288/RTI-23/CPIO/Estt. 45164 dated 09.11.2023.

DECISION

5. I have considered the appeal filed by the appellant viz-a-viz comments of DSP/HQs-cum-CPIO/Establishment. The undersigned being First Appellant Authority found that the CPIO has disposed of the RTI application while the recruitment was in under process. Moreover, CPIO/Establishment in her comments has submitted that the record of Constable recruitment 2023 is in the custody of Recruitment Cell. Therefore, CPIO/Establishment is hereby directed to transfer the RTI application to CPIO/Recruitment to supply a fresh reply to the applicant as per record. The appeal is hereby disposed of.
