**ORDER**

The appellant has preferred his 1<sup>st</sup> appeal against the reply of CPIO/East in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 51/UT/RTI/FAA/SSP dated 09.06.2020 for further proceeding under RTI Act.

**INFORMATION SOUGHT VIDE RTI APPLICATION:**

The appellant had sought information on 3 points i.e. whether Himachal Pradesh police shared any information on 08.10. & 09.10.2019, mobile tower location of mobile No. 9417276949 and CCTV footage of Himachal Bhawan, Sector 28, Chandigarh for dated 09.10.2019.

**COMMENTS OF CPIO/EAST:**

CPIO/East submitted that RTI application of the appellant was filed by his advocate Manpreet Singh, for supplying the requisite information. Accordingly report from SHO/PS-26 was obtained who reported that no such information was available in record. Accordingly, appellant was informed vide No. 580/CPIO/East dated 03.12.2019 in this regard.

**DECISION:-**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/East vis-à-vis material available on record which revealed that appellant had sought information on 3 points i.e. whether Himachal

Pradesh police shared any information on 08/09.10.2019, mobile tower location of mobile No. 9417276949 and CCTV footage of Himachal Bhawan, Sector 28, Chandigarh for dated 09.10.2019.

In reply, CPIO/East had informed that no such information is available in record.

So far as the appeal is concerned, it is clear from the reply of CPIO/East that requisite information is not available in record; therefore, the same cannot be supplied. With these observations, the instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
