ORDER

This is an order on the appeal preferred by Sh. Joginder Singh R/o H.No. 553/1, Sector 38/A, Chandigarh under RTI Act 2005, challenging the orders issued vide No. RTI-008/RTI-2020/CPIO/CCIC & IT dated 26.02.2020 by CPIO/CCIC & IT against the disposal of his RTI application dated 26.02.2020.

- 2. The appellant had filed an RTI application vide No. 162/RTI/CPIO(PHQ)/UT/PWS dated 29.01.2020 to I/C CCIC Sec-17 Chandigarh and the same was forwarded to the CPIO/CCIC & IT, Sector 17, Chandigarh for further necessary action. The appellant had sought some information pertaining to Public window No. 201908709 dated 15.05.2019.
- 3. The information sought by the appellant has been denied U/s 8(1) (j) of the RTI Act, as the appellant is neither complainant nor alleged in this complaint. Hence the application was disposed of by CPIO/CCIC & IT, Chandigarh, vide No. RTI-008/RTI-2020/CPIO/CCIC & IT dated 26.02.2020.
- 4. Now, Sh. Joginder Singh has challenged the said order and made an appeal against order No. RTI-008/RTI-2020/CPIO/CCIC & IT dated 26.02.2020.
- 5. Now, as per fresh report of I/C CCIC a case FIR No. 216 dated 19.12.2019 U/s 420, 120B IPC has already been registered at PS-Manimajra, Chandigarh and the PW Complaint No. 201908709 dated 15.05.2019 has been attached with the case file for

further investigation. Further this information has also been supplied to the appellant vide letter No. D-74/DSP/CCIC dated 22.05.2020.

4. I have gone through the RTI Appeal, vis-à-vis facts of the RTI application & comments by CPIO/CCIC & IT. The appellant had filed an RTI application dated 29.01.2020 seeking information in above mentioned PW complaint No. 201908709. The CPIO had disposed of the same on 26.02.2020 i.e. within stipulated period of 30 days by supplying the information to the complainant. Hence it cannot be said that the CPIO has denied the information or did not supplied it in time. The appeal is therefore rejected. However, to give justice to the appellant, the CPIO is directed to supply the information again through registered post.

The appellant, if not satisfied with the disposal of appeal in the manner as above can file second appeal to the CICC, New Delhi within a period of 90 days.
