ORDER


The appellant has preferred his 1st appeal through online portal (bearing No. PODEP/A/E/20/00049 dated 21.06.2020) against the reply of CPIO/South in connection with his RTI application (bearing No. PODEP/R/E/20/00204 dated 07.06.2020) with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 56/UT/RTI/FAA/SSP dated 22.06.2020 for further proceeding under RTI Act.

INFORMATION SOUGHT VIDE RTI APPLICATION:

The appellant had sought information on 4 points with regard to PW 202000314 & PW202000505 i.e. status of said complaints copy of DDR No. 18 & 72 dated 17.10.2018 etc.

COMMENTS OF CPIO/SOUTH:

CPIO/South submitted that RTI application of the appellant was received through online portal for supplying the requisite information. Accordingly, report from SHO/34 was sought who submitted that with regard to Point No. 1 & 2 PW 202000314 & PW202000505 was sent to senior officers after completion of enquiry and consigned with HAC Branch on 09.06.2020. With regard to point Nos. 3 & 4 DDR no. 18 & 72 are not related with the appellant, hence, denied u/s 8(1) (j) of RTI Act. Accordingly applicant was informed vide No. 214/CPIO/South dated 12.06.2020.

DECISION:

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that appellant had sought information on 4 points with regard to PW 202000314 & PW202000505 i.e. status of said complaints, copy of DDR No. 18 & 72 dated 17.10.2018 etc.

In reply, CPIO/South had denied the requisite information on point no. 3 & 4 to the appellant u/s 8(1) (J) of RTI Act.

So far as the appeal is concerned, it is clear that the current status of complaints in question i.e. PW 202000314 & PW202000505 were already supplied to the appellant by the CPIO as the same are now consigned with HAC Branch after completion of enquiry.

However, information of points No. 1 & 3 (i.e. copy of DDR No. 18 & 72 dated 17.10.2018) cannot be supplied to the appellant as the same are not related with the appellant, therefore, the same are rightly denied u/s 8(1) (J) of RTI Act being a third party information. Hence, no more action is required to be taken in the instant appeal and the same is hereby disposed off, accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
