

## THE SUPERINTENDENT OF POLICE HQs.-CUM-APPELLATE AUTHORITY-TRAINING, UNDER RIGHT TO INFORMATION ACT, 2005. Order on First Appeal u/s 19 RTI Act.

This is an order on the appeal dated 12.11.2019 preferred by Ms. Geeta R/o H. No. # 1666, Sector 8, Faridabad, Haryana under RTI Act 2005, received in this office on 13.11.2019 online, against disposal of her RTI application dated 13.09.2019 by CPIO/Training.

- 1. The appellant, who was an aspirant/candidate in recruitment of constables in Chandigarh Police, vide her RTI application dated 13.09.2019, requested CPIO/Training to supply her some information pertaining to Computer Based Test-2018. CPIO disposed off her RTI application vide No.RTI-153/DSP-Training on 05.10.2019.
- 2. The appellant, not satisfied with the manner in which her application was disposed of by the CPIO, filed the instant appeal alleging that CPIO refused her access to the information sought.
- 3. The comments of DSP-cum-CPIO/Training have been called for. She has reported that requisite information had been obtained from the office of SSP/Sec. & Traffic U/S 5(4)(5) of RTI Act and was supplied to the appellant in time.
- 4. I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments by CPIO/Training. The appellant, through RTI application, had sought information relating to Computer Based Test held for the recruitment of constables in Chandigarh Police. The appellant has also been contacted on her mobile number 9416740760 on 25.11.19 at 02.50 PM and offered personal hearing. She has expressed inability to travel to Chandigarh from Faridabad. The information sought by the appellant, supplied by the CPIO, grievance of the appellant and the order/decision of the undersigned being first appellate authority is given below:
