ORDER

DECISION:

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/South, Central & East vis-à-vis material available on record which revealed that appellant had sought the copy of complaint filed against him during the period 01.03.2020 to 10.05.2020

In reply, CPIO/South, Central & East informed that no such complaint was found registered against the appellant

So far as the appeal is concerned, it is clear from the CPIO/South, Central & East that no such complaint is found registered against the appellant.
