**ORDER**

This is an order in connection with First Appeal under RTI Act , preferred by of Sh. Arun Kumar Hooda S/o Dalvir Singh Hooda R/o # 4241, Sector- 46/D, Chandigarh under Section 19(1) of RTI Act-2005, received Email & by post in this office being dealt by CPIO/Rectt. & Trg and Establishment, against the disposal vide bearing No. RTI-15/DSP/Rectt. & Trg Dated 28.11.2023 and 335/RTI-23/CPIO/Estt/UT/47364 Dated 23.11.2023.

**Facts:-**

2. Vide RTI application dated 28.12.2023, the appellant had sought information in 03 different points, out of which point no. 1 & 2 were related to CPIO/Rectt. & Trg. and point no. 3 was related to CPIO/Establishment, which were as under:-

- 1) Kindly provide the attested copy of result showing Marks of Tier 1 & Tier 2 in the written Exam of Arun Kumar Hooda S/o Sh. Dalvir Singh ( Roll No. 2780703312) which was held on 27.08.2023 for the post of ASI Executive- 2023.
- 2) Kindly provide the attested copy of marks of the entire selected Candidate in the merit list and marks of candidate in waiting list for the post of ASI Executive - 2023 for the General Category Male candidates.
- 3) Kindly provide the action taken by the competent authority on the request of the applicant of Arun Kumar Hooda S/o Sh. Dalvir Singh Hooda ( Roll No. 2780703312) dated 04.10.2023 and 09.10.2023 regarding postponement of Physical Endurance and Measurement Test which was sent through E-mail and Action taken by the competent authority on the legal notice dated 06.10.2023 sent on behalf of Arun Kumar Hooda S/o Sh. Dalbir Singh Hooda (Roll No. 2780703312) through E-mail as well as Original Hard copy to the office of Sr. Supt. of Police, Union Territory, Chandigarh.

3. The appellant is not satisfied with the information supplied by the CPIO/Rectt. & Trg. and CPIO/Establishment against his RTI application and has filed the instant appeal mentioning therein that the information sent by the Centre Public Information Officer is incomplete.

4. The Comments of CPIO/Rectt. & Trg. and CPIO/Establishment were sought, vide No D-1094-95/RTI/SP/Hqrs. dated 29.12.2023. The comments received are as under:-

**Comments of CPIO/Rectt. & Trg.**

CPIO/Rectt. & Trg. intimated that the said RTI application was transferred by CPIO/Estt., vide no. 335.RTI-23/CPIO/Estt./UT/46042 dated 20.11.2023, to provide part information u/s 6(3) of Right to Information Act 2005 with respect to point no. 1 & 2. The requisite information was sought from the In-charge Recruitment Cell and the same was provided to the applicant vide No. RTI-15/DSP/Rectt. & Trg. dated 28.11.2023. Wherein, the marks of applicant in Tier-1 & Tier-2 sought w.r.t. point No. 1 has already been supplied and the desired information w.r.t. point no. 2 was denied under section 8(1) (j).

**Comments of CPIO/Establishment**

CPIO/Establishment intimated that the information w.r.t. point No. 03 has already been supplied to the appellant i.e. the legal notice have been considered and filed by the competent authority, vide office letter No. 335/RTI-23/CPIO/Estt/UT/46042 dated 20.11.2023.

**DECISION**

5. I have considered the appeal filed by the appellant viz-a-viz comments of CPIO/ Rectt. & Trg. and Establishment. The undersigned being First Appellate Authority found that the information on point 01 and 03 has already been supplied to the applicant. But information w.r.t. point No. 02 was denied by CPIO/Recruitment. Therefore, CPIO/ Recruitment is hereby directed to supply the information against point No. 02, if available on records. The appeal is hereby disposed of, accordingly.-
