## ORDER

The appellant has preferred his 1st appeal vide two separate communications on similar matter against the reply of CPIO/W&CSU in connection with his RTI application dated 27.05.2020, received on 11.06.2020 with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 66 & 69/UT/RTI/FAA/SSP dated 20 & 23.07.2020 respectively for further proceeding under RTI Act.

## INFORMATION SOUGHT VIDE RTI APPLICATION:

The appellant had sought copy of Power of Attorney attached in complaint bearing No. PW2020-02746 lodged by her wife Meenakshi Sharma through her Lawyers Rajiv Malhotra, S.S. Boparai and Saurabh Chawla in Women Cell.

## Comments of CPIO/W&CSU:

CPIO/W&CSU submitted that RTI application of the appellant was received from CAPIO(PHQ) vide No. 501-RTI/R/CAPIO/(PHQ)/UT/PWS dated 11.06.2020 for supplying the requisite information. Thereafter, requisite information was obtained from SHO/WPS-17 who reported that complaint in question i.e. PW2020-02746 was under enquiry, therefore, the same was denied u/s 8(1) (h) of RTI Act vide letter no. RTI-174/UT/DSP/W&CSU dated 18.06.2020.

CISION:

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/W&CSU vis-à-vis material available on record which revealed that appellant had sought copy of Power of Attorney attached in complaint bearing No. PW2020-02746 lodged by her wife Meenakshi Sharma through her Lawyers Rajiv Malhotra, S.S. Boparai and Saurabh Chawla in Women Cell.

In reply, CPIO/W&CSU denied the requisite information u/s 8(1) (h) of RTI Act to the appellant.

So far as the appeal is concerned, appellant has sought the copy of Power of Attorney of Advocate Rajiv Malhotra & others through which complaint bearing No. 202002746 was lodged by his wife. The same can be supplied to the appellant during the course of enquiry. Hence, CPIO/W&CSU is hereby directed to provide copy of Power of Attorney to the appellant as per RTI Act.

With these observations, the instant appeal is hereby disposed of, accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
