ORDER

The appellant has preferred his 1st appeal through online portal (bearing No. PODEP/A/E/20/00061 dated 26.07.2020) against the reply of CPIO/Central in connection with his RTI application (bearing No. PODEP/R/E/20/00245 dated 01.07.2020) with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 78/UT/RTI/FAA/SSP dated 28.07.2020 for further proceeding under RTI Act.

INFORMATION SOUGHT VIDE RTI APPLICATION:

The appellant had sought copy of complaint bearing No. PW202009937 dated 17.06.2020 given by Amar Vivek along with documents annexed with it.

COMMENTS OF CPIO/CENTRAL:

CPIO/Central submitted that RTI application of the appellant was received through online portal for supplying the requisite information. After taking the report from SHO/PS-03, copy of complaint No. PW202009937 was supply to him vide letter No. 171/RTI-20/CPIO-Central/UT dated 14.07.2020.

DECISION:

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Central, vis-à-vis material available on record which revealed that appellant had sought copy of complaint bearing No. PW202009937 dated 17.06.2020 given by Amar Vivek along with documents annexed with it.

In reply, CPIO/Central had supplied copy of complaint to the appellant.

So far as the appeal is concerned, appellant has contended that he has received the copy of complaint bearing No. PW202009937 but documents annexed with the said complaint had not supplied to him. Hence, CPIO/Central is hereby directed to supply documents annexed with the complaint (bearing No. PW202009937) to the appellant, if any, as per RTI Act.

With these observations, the instant appeal is hereby disposed of, accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
