**ORDER**

The appellant has preferred his 1<sup>st</sup> appeal against the reply/order of CPIO/W&CSU with the contentions that requisite information was not supplied to him. The same was diarized vide No. R-754/UT/RTI/SSP dated 20.12.2018.

**Information sought vide RTI application:**

The appellant had sought copy of complaint bearing No. PW201819758 made by Dr. Jasneet Kaur against him.

**Comments of CPIO/W&CSU:**

CPIO/W&CSU submitted that RTI application was received in his office directly from the appellant. Thereafter comments of SHO/WPS were obtained and the requisite information i.e. copy of complaint (PW201819758) along with its annexures containing four (04) pages were supplied to the appellant vide letter No. 598/DSP/W&CSU dated 11.12.2018. As far as appeal is concerned CPIO submitted that nothing is left on his part for supplying to the appellant.

**Decision:**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/W&CSU vis-à-vis material available on record which revealed that the appellant had sought copy of complaint bearing No. PW201819758 made by Dr. Jasneet Kaur against him.

In reply, CPIO/W&CSU had supplied the copy of complaint along with its annexure to the appellant.

So far as the appeal is concerned, CPIO has asserted that appellant has been provided copy of complaint along with its annexures (containing 4 pages) and nothing is left on his part for supplying to the appellant.

Moreover, it is also pertinent to mention here that appellant has ~~sought~~ only copy of complaint filed against him. He has not sought any annexure vide his RTI application. Yet, copy of complaint along with annexure (4 pages) was supplied by CPIO.

In view of above, no more action is required to be taken in the instant and the same is hereby filed accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, as above, he can file second appeal within 90 days before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act.
