ORDER

The appellant has preferred his 1st appeal against the reply/order of CPIO/Central, East and South in connection with his RTI application dated 10.04.2019 with the contentions that complete information was not supplied to him. The same was diarized vide No. R-90/UT/RTI/FAA/SSP dated 22.05.2019 for further proceeding under RTI Act.

Information sought vide RTI application :

The appellant vide his RTI application, had sought information on 03 points pertaining to cases/FIRs registered against Juveniles during the last ten years (from 2009 to the date of RTI application) regarding heinous crimes e.g. murder, rape, POCSO Act, NDPS act etc.

Comments of CPIO/Central, East and South :

In this regard, comments of CPIO/Central, East and South have been obtained who submitted that the requisite information was obtained from all the SHOs of their respective Sub Divisions and the same was supplied to the appellant. As far as appeal is concerned, they submitted that available information at their disposal has already been sent to the appellant.

Decision :

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Central, East and South vis-à-vis material available on record which revealed that the appellant vide his RTI application, had sought information on 03 points pertaining to cases/FIRs registered against Juveniles during the last ten years (from 2009 to the date of RTI application) regarding heinous crimes e.g. murder, rape, POCSO Act, NDPS

act etc. out of three points, point nos. 1 and 3 are related to the office of the undersigned. With respect to point no. 02, instant appeal was transferred to FAA-cum-SSP/Security & Traffic, UT Chandigarh as the same was related to CPIO/Traffic.

In reply to RTI application, CPIO/Central, East and South had supplied the requisite information to the applicant after obtaining the same from all the SHOs of their respective Sub Divisions.

So far as the appeal is concerned, all the CPIOs have submitted that available information at their disposal has already been sent to the appellant whereas appellant has alleged that incomplete information was supplied to him.

It is also pertinent to mention here that although all the CPIOs have supplied the available information at their disposal but the pattern of information sent, was altogether different from each other which created confusion.

Hence, all the CPIOs are hereby directed to examine their record thoroughly and supply the requisite information to the appellant in a single pattern in liaisoning with each other, without disclosing personal detail of Juveniles, in accordance with RTI act. They are further directed to liaise with each other in future also, before supplying such type of common information to the applicants.

With these observations, the appeal is disposed of accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
