ORDER

The appellant has preferred his 1st appeal against the reply/order of CPIO/East & PHQ in connection with his RTI application with the contentions that requisite information was not supplied to him. The same was diarized vide No. R-97/UT/RTI/FAA/SSP dated 28.05.2019 for further proceeding under RTI Act.

Information sought vide RTI application :


The appellant has sought copy of complaint filed against him by Sonu @ Gurmeet Singh and Dinesh along with copy of statements of complainant recorded in the enquiry.

Comments of CPIO/East :

CPIO/East submitted that RTI application of the appellant was received from CAPIO(PHQ) vide letter no. 857/RTI/CAPIO(PHQ)/UT/PWS dated 12.04.2019 for obtaining information with regard to complaint No. 2019-04054 & 2019-04946. After obtaining the report from SHO/PS Sector 19, the copy of complaint No. 2019-04946 was supplied and also informed that no statement has been recorded. However, with regard to complaint No. 2019-04054, RTI application was transferred to CPIO/PHQ as the enquiry report was already submitted to Senior Officer.

Comments of CPIO/PHQ :

CPIO/PHQ submitted that RTI application of the appellant was received in his office CPIO/East for providing information with regard to complaint No. 2019-04054. Thereafter, requisite information was obtained from the I/C CRU who submitted that complaint in question was under consideration for decision therefore, the same could not be supplied at that time. Accordingly, appellant was informed vide letter No. 681/DSP/Hqrs/RTI-

Decision :

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/East & PHQ vis-à-vis material available on record which revealed that the appellant had sought copy of complaint filed against him by Sonu @ Gurmeet Singh and Dinesh along with copy of statements of complainant recorded in the enquiry.

In reply, CPIO/East, supplied the requisite information w.r.t. complaint No. 2019-04946 to the appellant. However, information pertaining to complaint No. 2019-04054 had already sent to senior officer therefore, RTI application was transferred to CPIO/PHQ for its proper disposal.

CPIO/PHQ had denied the requisite information as compliant in question was under consideration for decision at that time.

So far as the appeal is concerned, CPIO/PHQ has submitted that complaint in question i.e. 2019-04054 was disposed of and presently consigned with HAC branch. Therefore, the same can be supplied to the appellant.

In view of above, CPIO/PHQ is hereby directed to supply the requisite information relating to complaint No. 2019-04054 to the appellant as per RTI Act.

Moreover, CPIO/East has already supplied the requisite information to the appellant. Hence, no more action is required in the instant appeal. With these observations, the instant appeal is disposed of accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, she can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
