### ORDER

The appellant has preferred his 1st appeal against the reply of CPIO/Central in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal is diarized vide No. 77/UT/RTI/FAA/SSP dated 28.07.2020 for further proceeding under RTI Act.

## INFORMATION SOUGHT VIDE RTI APPLICATION:

The appellant had sought copy of complaint along with annexure filed against him by Sh. Rabindranath Singh s/o Late Sh. Baboo Singh C/o PIP Singh Advocate, House No. 567, Phase 10, Mohali.

## COMMENTS OF CPIO/Central:

CPIO/Central submitted that RTI application of the appellant was received for supplying the requisite information pertaining to PW complaint No. 201923002 dated 27.11.2019. Thereafter requisite information was obtained from SHO/PS-17 and the requisite information was denied to the appellant u/s 8(1)(h) of RTI act vide letter no. 105/RTI-20/CPIO/Central dated 20.03.2020.

#### DECISION:

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record which revealed that appellant had sought copy of complaint along with annexure filed against him by Rabindranath Singh s/o Late Sh. Baboo Singh C/o PIP Singh Advocate, House No. 567, Phase 10, Mohali.

In reply, CPIO/Central had denied the requisite information to the appellant u/s 8(1)(h) of RTI act.

So far as the appeal is concerned, appellant had contended that he needs the copy of complaint bearing No. 201923002 along with its annexure for submitting the reply to the allegations levelled against him in the said complaint. Hence, the same can be supplied to the appellant and accordingly, CPIO/Central is hereby directed to supply the copy of the above complaint along with its annexures, (if any, attached with complaint) to the appellant as per RTI Act. With this direction, the instant appeal stands disposed of.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
