ORDER

The appellant has preferred her 1st appeal against the reply/order of CPIO/East and Hqrs in connection with her RTI application with the contentions that requisite information was not supplied to her. The same was diarized vide No. R-96/UT/RTI/FAA/SSP dated 28.05.2019 for further proceeding under RTI Act.

Information sought vide RTI application:

The appellant has sought that how many times five different persons (mentioned in the RTI Application) were summoned in the Police Station 19 with regard to her complaints made to DGP & SSP, Chandigarh w.e.f. 6th October, 2017 to till date i.e. 07th May, 2019.

Comments of CPIO/Hqrs:

CPIO/Hqrs submitted that applicant vide his RTI dated 08.05.2019 had sought information pertaining to how many times five different persons (names mentioned in the RTI Application) were summoned in the Police Station 19 with regard to her complaints made to DGP & SSP, Chandigarh w.e.f. 6th October, 2017 to till date i.e. 07th May, 2019. Thereafter, I/C HAC was directed to submit the requisite information who reported that all relevant complaints have been sent to DSP/Crime for further necessary action. Accordingly, RTI application was transferred to CPIO/Crime vide letter no. 779/DSP/Hqrs/RTI-19/D-923 dated 07.06.2019. With respect to remaining information, RTI application was also transferred to CPIO/East vide letter no. 779/DSP/Hqrs/RTI-19/D-935 dated 14.06.2019. The appellant was informed accordingly.

Comments of CPIO/East:

CPIO/East submitted that RTI application of the appellant was received from CAPIO(PHQ) vide no. 1060/RTI/CAPIO(PHQ)/UT/PWS dated 08.05.2019. Thereafter, report was obtained from SHO/PS Sector 19 as all the complaints made by Ms. Sunila Kohli were dealt in PS - 19. In this regard, SHO/PS-19 submitted that no complaint of Ms. Sunila Kohli was pending with PS-19 at that time, therefore, requisite information is not available with his office. All the complaints were sent to senior officers after completion of enquiries. Moreover, it is also informed that most of the time telephonic messages were conveyed to the concerned persons for joining the enquiry.


Decision:

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Hqrs and East vis-à-vis material available on record which revealed that the appellant had sought information pertaining to how many times five different persons (names mentioned in the RTI Application) were summoned in the Police Station 19 with regard to her complaints made to DGP & SSP, Chandigarh w.e.f. 6th October, 2017 to till date i.e. 07th May, 2019.

In reply to the RTI application, CPIO/Hqrs submitted that all the complaints of the appellant which were consigned to HAC branch, were sent to DSP/Crime for further necessary action. Accordingly, RTI application was transferred to CPIO/Crime. Moreover, RTI application was also transferred to CPIO/East. Applicant was apprised accordingly.

CPIO/East submitted that no complaint of Ms. Sunila Kohli was pending with PS-19 at the time of disposal of RTI application, therefore requisite information was not available with his office. All the complaints were sent to senior officers after completion of enquiries.

In view of aforementioned facts and comments submitted by both the CPIOs, it is clear that all the complaints upto 07.05.2019 (date of filing of RTI application) alongwith necessary documents were transferred to CPIO/Crime for further necessary action. Regarding these complaints no information is available with the CPIOs and appellant has also been informed accordingly by both the CPIOs.



Hence, requisite information i.e. number of times of summoning of five different persons, is not available at the disposal of CPIOs, so the same cannot be supplied at this stage. However, for the satisfaction of the appellant, CPIO/Hqrs is hereby directed to arrange the inspection of the relevant complaints files, as and when the same were received back from CPIO/Crime, if any case FIR is not registered in the matter and supply the requisite information, as per RTI act. Moreover, appellant is also advised to approach the office of CPIO/Crime for obtaining his information. With these observations, the instant appeal stands disposed of accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, she can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
