ORDER

The appellant has preferred his online 1st appeal vide registration no. PODEP/A/E/20/00063 dated 08.08.2020 against the reply/order of CPIO/East in connection with his RTI application bearing registration no. PODEP/R/E/20/00273 dated 11.07.2020 with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide no. 81/UT/RTI/FAA/SSP dated 08.08.2020 for further proceeding under RTI Act.

Information sought vide RTI application:-

The appellant had sought the information pertaining to his complaint filed in October, 2016 regarding theft against his wife Smt. Jyoti and in-laws namely Shivam, Smt. Sunita, Smt. Manisha & others i.e. all statements, summons, action taken reports & other attached documents etc.

Comments of CPIO/East :-

Comments of CPIO/East have been obtained who submitted that RTI application of the appellant was received in his office through online RTI portal vide registration no. PODEP/R/E/20/00273 dated 11.07.2020. Thereafter, requisite information was obtained from PS Sector 26, Chandigarh and the same was supplied to the appellant on 06.08.2020. As far as the appeal is concerned, appellant has mentioned additional facts which were not earlier mentioned in his RTI application dated 11.07.2020 and demanded information about these new facts vide his instant appeal dated 08.08.2020.

Decision :-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/East vis-à-vis material available on record which revealed that the appellant vide his online RTI application dated 11.07.2020 had sought information pertaining to his complaint filed in October, 2016 regarding theft against his wife Smt. Jyoti and in-laws namely Shivam, Smt. Sunita, Smt. Manisha & others i.e. all statements, summons, action taken reports & other attached documents etc.

In reply, CPIO/East had supplied the requisite information to the appellant.

So far as the appeal is concerned, appellant has mentioned additional facts/grievances which were not earlier mentioned in his RTI application dated 11.07.2020 and demanded information about these new facts vide his instant appeal dated 08.08.2020 which is contrary to the provisions of RTI act, 2005, hence not maintainable. As per RTI act, an appeal against an RTI application can only be entertained against the information demanded in that particular RTI application.

However, in the interest of justice, CPIO/East is hereby directed to arrange the inspection of relevant available information regarding the complaint of the appellant and supply the remaining information, if any, to him as per RTI act. With these observations, the instant appeal stands disposed of accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
