ORDER

The appellant has preferred his online 1st appeal vide registration no. PODEP/A/E/20/00064 dated 13.08.2020 against the reply/order of CPIO/East in connection with his RTI application bearing registration no. PODEP/R/E/20/00278 dated 16.07.2020 with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide no. 83/UT/RTI/FAA/SSP dated 14.08.2020 for further proceeding under RTI Act.

Information sought vide RTI application :-

The appellant had sought the certified copy of reply of Mr. Rajiv Aggarwal in connection with his complaint bearing no. 2019-21017 dated 31.10.2019.

Comments of CPIO/East :-

Comments of CPIO/East have been obtained who submitted that RTI application of the appellant was received in his office through online RTI portal vide registration no. PODEP/R/E/20/00278 dated 16.07.2020. Thereafter, requisite information was obtained from SHO PS Sector 26 and the same was supplied to the appellant through online portal on 22.07.2020. However, the appellant was called personally in the office by CPIO/East and supplied the requisite information again to the appellant on 18.08.2020.

Decision :-


I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/East vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought the certified copy of reply of Mr. Rajiv Aggarwal in connection with his complaint bearing no. 2019-21017 dated 31.10.2019

In reply, CPIO/East had supplied the requisite information to the appellant through online RTI portal.

So far as the appeal is concerned, the appellant was called personally in the office by CPIO/East and supplied the requisite information again to the appellant on 18.08.2020.

In view of above, no more action is required to be taken on the instant appeal, the same is hereby disposed of accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
