ORDER

The appellant has preferred his 1st appeal through RTI portal bearing No. PODEP/A/2019/60031 dated 29.05.2019 against CPIO/Central in connection with his RTI application (bearing No. PODEP/R/2019/50347 dated 29.04.2019) with the contentions that requisite information was not supplied to him. The same was registered vide No. 101/UT/RTI/FAA/SSP dated 29.05.2019.

Information sought vide RTI application :

The appellant had sought the status of his complaint lodged at public grievance portal bearing No. GOVCC/E/2019/00127.

Comments of CPIO/Central:

CPIO/Central submitted that RTI application of the appellant was received through online RTI portal bearing No. PODEP/R/2019/50347 dated 29.04.2019. In this regard, requisite information was obtained from SHO/PS-03, who submitted that complaint in question i.e. 2019-05510 dated 30.03.2019 has already been sent to senior officer on 27.04.2019 with the recommendation that the matter is civil in nature. Accordingly appellant was informed in this regard by post on 15.05.2019 as well as online portal. As far as appeal is concerned, the present status of the complaint on Public Window portal is with HAC branch.

DECISION :

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record which revealed that the appellant had sought the status of his complaint lodged at public grievance portal bearing No. GOVCC/E/2019/00127.


In reply, CPIO/Central informed the appellant that complaint No. 2019-05510 dated 30.03.2019 was sent to senior officer on 27.04.2019 with the recommendation that the matter is civil in nature.

So far as the appeal is concerned, complaint in question i.e. 2019-05510 dated 30.03.2019 was sent to senior officer after enquiry, therefore, CPIO/Central should have transfer the RTI application to the concerned CPIO for proper disposal of RTI application. At present the complaint in question is consigned with HAC branch after completion of enquiry therefore, the same can be supplied to the appellant.

Hence, CPIO/Central is hereby directed to arrange the inspection of the relevant after obtaining from the same from HAC branch and supply the requisite information to the appellant as per RTI Act.

With these observations, the instant appeal is hereby disposed of accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, as above, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067 under the RTI Act within 90 days.
