**ORDER**

The appellant has preferred his 1<sup>st</sup> appeal on 17.08.2020 (received on 20.08.2020) in connection with his RTI application dated 26.06.2020, received on 01.07.2020 with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide no. 85/UT/RTI/FAA/SSP dated 20.08.2020 for further proceeding under RTI Act.

**Information sought vide RTI application :-**

The appellant had sought information on seven (07) points pertaining to his complaint bearing no. 2020-02751 i.e. copy of complaint, annexures, statements, summons and action taken report etc.

**Comments of CPIO/Central :-**

Comments of CPIO/Central have been obtained who submitted that RTI application of the appellant was received in his office through CAPIO/PHQ-cum-I/C Public Window vide letter no. 548/RTI/CAPIO/PHQ/UT/PWS dated 01.07.2020 and the requisite information was obtained from quarter concerned. Thereafter, the same was supplied to the appellant through special messenger on 31.08.2020.

**Decision :-**

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought information on seven (07) points pertaining to his complaint bearing no. 2020-02751 i.e. Copy of complaint, annexures, statements, summons and action taken report etc.

In reply, CPIO/Central had supplied the requisite information to the appellant through special messenger on 31.08.2020.

So far as the appeal is concerned, the requisite information has been supplied to the appellant on 31.08.2020 but till then appellant has filed his 1<sup>st</sup> appeal before the undersigned on 17.08.2020 which is received on 20.08.2020. Hence, it is clear that requisite information should have been supplied earlier to the appellant within 30 days from the date of filing of RTI application.

In view of above, no more action is required to be taken on the instant appeal. However, CPIO/Central is hereby directed to remain careful in future and strictly adhere to the provisions of RTI act, 2005. With these observations, the instant appeal stands disposed of accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
