ORDER

The appellant has preferred his 1st appeal against the reply/order of CPIO/South in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 02/UT/RTI/FAA/SSP dated 13.01.2020 for further proceeding under RTI Act.

Information sought vide RTI application:

The appellant had sought information on 04 points with regard to FIR No. 421 dated 20.11.2019, PS-39, Chandigarh i.e. recovery of stolen goods, latest status of FIR, action taken after registration of FIR and No. of person arrested.

Comments of CPIO/South:

CPIO/South submitted that RTI application of the appellant was received on 11.12.2019 for supplying the requisite information. Thereafter, requisite information was obtained from SHO/PS-39 and point-wise information was sent to the applicant vide no. 798/CPIO/South dated 14.12.2019.

Decision:

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that the appellant had sought information on 04 points with regard to FIR No. 421 dated 20.11.2019, PS-39, Chandigarh i.e. recovery of stolen goods, latest status of FIR, action taken after registration of FIR and No. of person arrested

In reply, CPIO/South had submitted that point wise information was provided to the appellant.

Insofar, the instant appeal is concerned, appellant has raised his grievances with regard to case FIR No. 421 dated 20.11.2019, PS-39, Chandigarh which is not covered under RTI Act. However, CPIO/South has supplied the point-wise requisite information to the appellant. Hence, the instant appeal is hereby filed, accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
