ORDER

The appellant has preferred his online 1st appeal vide registration No. PODEP/A/E/20/00066 dated 28.08.2020 against the reply/order of CPIO/W&CSU in connection with his RTI application bearing registration No. PODEP/R/E/20/00329 dated 06.08.2020 with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide no. 89/UT/RTI/FAA/SSP dated 28.08.2020 for further proceeding under RTI Act.

Information sought vide RTI application :-

The appellant had sought information on four points pertaining to his complaint bearing no. 2019-23132 i.e. copy of complaint, MLR report, copies of his emails from 28.12.2019 and all investigation reports etc.

Comments of CPIO/W&CSU :-

Comments of CPIO/W&CSU have been obtained who submitted that online RTI application of the appellant was received in his office on four points and the requisite information was obtained from SHO/WPS. Thereafter, the part information i.e. copy of complaint & emails was supplied, however, MLR report & investigation report was denied u/s 8(1)(h) of RTI Act to the appellant.

Decision :-


I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/W&CSU vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought information on four points pertaining to his complaint bearing no. 2019-23132 i.e. copy of complaint, MLR report, copies of his emails from 28.12.2019 and all investigation reports etc.

In reply, CPIO/W&CSU had supplied the part information and part information was denied u/s 8(1)(h) of RTI Act to the appellant.

So far as the appeal is concerned, it is clear that complaint in question i.e. 2019-23132 is still under enquiry and copy of the said complaint & others emails sent by appellant have already been supplied. Hence, CPIO/W&CSU had rightly denied the part information by applying section 8(1)(h) of RTI Act to the appellant.

In view of above, no more action is required to be taken on the instant appeal and the same is hereby disposed of.


